## **Missing Middle Messes and Successes • 1.25 CM**

The panel will focus on how to achieve increased density with “missing middle” housing types via zoning reforms. Panel discussion will include compare and contrast examples of Walla Walla and Olympia's processes as they worked through these zoning reforms with varying levels of success. Topics during the panel discussion will include research, public involvement, implementation, and next steps. PowerPoint accompanying panel discussion will include visuals of missing middle housing types in Olympia and Walla Walla and how they mesh into existing single-family home neighborhoods. Handouts will include a “Zoning Change FAQ” that Walla Walla published after their code change was enacted. Panel will include suggestions about how planners can use the experiences of Walla Walla and Olympia to pass zoning code changes to meet Washington State Bill E2SHB 1923 that provides grant funding and protects against appeals in order to

increase the supply of affordable housing. Attendees will leave the panel session empowered to bring zoning code reform for missing middle housing to their jurisdictions.

### ***Addressing Sea Level Rise in Coastal Planning for Washington State • 1.25 CM***

Washington coastal communities are experiencing increasing flooding impacts. Projections for future conditions indicate the impacts from storm surge will only be exacerbated with increasing sea levels. In response, local governments are looking for ways to use both regulatory and non-regulatory approaches to manage land uses and adapt to address future impacts. Three communities, Tacoma, King and Island County, will share in this session approaches they are exploring that would incorporate best management practices, consider coastal hazard zones, and determine how to incorporate sea level rises into comprehensive plans, shoreline master programs, capital facilities planning and other regulatory tools affecting uses of land in these coastal areas. The session will begin with an overview and explanation of localized sea level rise projections for Washington state, a description of approaches from other states and jurisdictions, and an explanation of ideas being considered by Tacoma, King and Island County.

### ***Urban Alchemy: Placemaking from Scratch • 1.25 CM***

Placemaking is easy enough when there is good urban fabric. But what do you do in the neglected spaces, the urban “ugly ducklings?” Jeff Arango will talk about several examples of placemaking in challenging locations, including Colonial Plaza in Lakewood and streets and alleys in Seattle neighborhoods. Like many newer cities, Lakewood lacks the historic “main street” that supports pedestrian places with strong character. Underutilized Motor Avenue offered a promising location to create a walkable node for the city. Construction was completed in 2019, with art currently being designed. Framework has been instrumental in rethinking the use of alleys, including Nord Alley in Pioneer Square, Canton Alley in Chinatown, and Neighbours Alley in Capitol Hill. Each of these have different cultural contexts and stewards, which have affected the planning and design.
